## Appeal of ComReg's Decision on Market Reviews: Wholesale Local Access and Wholesale Central Access and ComReg's Decision on Pricing of Wholesale Broadband Services in the WLA and WCA Markets

1. On 19 November 2018, the Commission for Communications Regulation ("ComReg") published ComReg Decision D10/18<sup>1</sup> and ComReg Decision D11/18<sup>2</sup> (collectively "the Decisions"). ComReg Decision D10/18 designated Eircom Limited ("Eircom") with significant market power on the Wholesale Local Access ("WLA") Market and Regional Wholesale Central Access ("WCA") Market and imposed a number of obligations on Eircom. ComReg Decision D11/18, among other things, further specified cost-orientation and transparency obligations imposed on Eircom in D10/18.
2. Sky Ireland Limited ("Sky") lodged an appeal to the Decisions<sup>3</sup> on 14 December 2018. Notwithstanding this they remain in force in their entirety. For the avoidance of doubt, any price changes necessitated by the Decisions will come into effect as provided in the Decisions and as provided for in ComReg Document 18/101.
