

Eircom Accounting Separation HCA and CCA separated accounts

Under ComReg Decision D08/10¹, on Accounting Separation and Cost Accounting obligations, Eircom is required to publish HCA and/or CCA separated accounts for its financial year ending 30th June 2012.

HCA separated accounts

Eircom has requested that the publication date of the HCA separated accounts for the year ended 30 June 2012 be extended from 30 November 2012 to 21 December 2012. This is because of the continued transition of the underlying Regulatory Accounting Model to support the new reporting structures.

CCA separated accounts

Eircom has also requested that it receives derogation from preparing, auditing and publishing CCA separated accounts for the year ended 30 June 2012. This will enable it to allocate resources to other key areas in its regulatory audit process. CCA information will, however, be available for ComReg if required.

ComReg has acceded to both of these requests.
