1. On 22 October 2020, ComReg published Consultation Document 20/101¹ on Eircom's regulated wholesale fixed access charges which included proposed revised FTTC prices and CG Bitstream prices following updates made to the NGA Cost model. The deadline for the Consultation is 5pm on 4 December 2020.
2. As noted in ComReg Consultation Document 20/101,² TERA consultants assisted ComReg in assessing the impact of the updates made to the NGA Cost model.
3. ComReg received a request from an interested party for access to the NGA Cost model and any report produced by TERA consultants in relation to the assessment of the impact of the ANM cost review and updated WACC³ on FTTC prices and CG Bitstream prices.
4. ComReg has agreed to share a non-confidential version of the NGA Cost model and a note on that model which had been prepared by TERA. It is also prepared to share these with any other interested party on request.
5. To receive a copy of the non-confidential NGA Cost model and the TERA note please contact ComReg's regulatory pricing team.⁴
