1 Invitation to Tender

1.1 Requirement

Provision of professional services:

- To provide detailed economic advice on the options for the optimal strategy for the release of spectrum in the 900 MHz band in order to achieve the Commission for Communications Regulation's ("the Commission") statutory objectives.
- The analysis should present; a consideration of the costs in terms of the running and administration of any chosen auction methodology, as well as the benefits of each auction type being considered for the future of the 900 MHz band: highlighting the one(s) that will best allow the Commission to fulfil its statutory objectives.
- To submit an interim and subsequent final written report to the Commission;
 and
- To liaise with staff of the Commission and its advisors as necessary during any subsequent release of spectrum in the 900 MHz band.

1.2 Awarding Authority

The Commission for Communications Regulation Block D, E and F Abbey Court Irish Life Centre Lower Abbey Street Dublin 1 Ireland

1.3 Overview of the Requirement

The Commission has responsibility under the Communications Regulation Act, 2002 as amended, for the issue of licences under the Wireless Telegraphy Act 1926 as amended and General Authorisations for electronic communications networks and services. These include licences issued to mobile telephony networks using both the 2G (GSM) and 3G (IMT 2000) standards. Currently, each mobile operator's licence contains standard provisions obliging the licensee to offer a guaranteed minimum level of quality of service (QoS), and to meet certain specified minimum roll-out requirements. The requirements contained in these licences are detailed in Appendix 3 of this document.

The purpose of this Invitation to Tender (ITT) is to provide detailed economic advice; on the options for the optimal strategy for the release of spectrum in the 900 MHz band. The analysis in general should include and present; a consideration of the costs in terms of the running and administration of any chosen auction methodology, as well as the benefits of each auction type being considered for the future of the 900 MHz band: highlighting the one(s) that will best allow the Commission to fulfil its statutory objectives.

The Commission now invites tenders from suitably qualified persons to provide these professional services. The successful tenderer(s) will be required, subject to contract, to carry out this analysis on the Commission's behalf.

For the avoidance of doubt, the use of the word "<u>must</u>" anywhere in this document indicates a mandatory requirement to be satisfied in tender submissions. Failure to comply with any single mandatory requirement will result in disqualification of the tender.

Tenderers **must** sign the checklist in Appendix 4 and include it in the tender submission.

Tenderers should clearly demonstrate their ability to conduct the analysis, but at a minimum tenders **must** include the following;

- A statement on the tenderer's understanding of the requirement and knowledge of the associated documents (Interested parties are referred to Appendix 3);
- The professional qualifications and relevant training of the proposed project personnel and support personnel;
- Details of any equipment, software or modelling tools to be used;
- A statement on the tenderer's knowledge of relevant European initiatives for "spectrum liberalisation" in the 900 MHz and 1800 MHz bands including those at the European Commission (EC), the Conference of European Postal and Telecommunications Administrations (CEPT) and in any other European States; and
- Details of similar work completed to-date, including any samples which can be provided.

1.4 Provision of Information

The Commission proposes to release the following information relating to this ITT, on request:

- The name and address of the successful tenderer, and
- Overall contract value of the successful tender.

Under the Freedom of Information Act, 1997 (as amended) information provided in this ITT may be disclosed where a request is made for access to records and where the public interest value of releasing such information is deemed to outweigh the right to confidentiality. It is the responsibility of tendering parties to specify to the Commission any information which they do not wish to be disclosed. The Commission will consult with the relevant tenderer before making any decision on releasing such information in response to a request under the Freedom of Information Act 1997 (as amended).

The Commission undertakes to hold confidential any information provided by tenderers subject to:

- Disclosure of the information specified above as being information that will be released on request; and
- The Commission's obligations under law, including the Freedom of Information Act, 1997 (as amended).

1.5 Tender and Contractual Arrangements

The solution offered may involve the provision of services from either a single party or a group/consortium of bidders. Where a tender is based on a group/consortium of business interests, the tender **must** also identify:

- The prime partner in the group/consortium;
- The number of parties involved and names of each party; and
- The proposed arrangements for its operation, including the nature and area of participation of each party in the context of the contract in question.

Where a tender from a group or consortium of bidders is selected as the preferred bid, the Commission will enter into negotiations with a view to concluding a contract with the prime contractor within that group or consortium, who will then take responsibility for all matters arising under the contract.

The Commission reserves the right to select individual components from tender(s) and upon agreement with the tenderer to comprise a total solution as relevant.

All prices must be quoted in Euro and must be provided inclusive of VAT².

2 Requirements of Contract

2.1 General Requirements

This specification contains details of the minimum requirements of this ITT. Tenders should clearly demonstrate that these requirements can be met. Proposals above the minimum requirements should be detailed in the response and may attract extra marks. However any further and associated costs **must** be detailed separately.

Tenders should clearly establish the tendering party's track record and capability for providing a professional, high quality, accurate and compliant service similar to the services required in this ITT.

Award of the contract will be dependent upon compliance by the successful tenderer with the tax clearance requirement of Irish public sector contracts procedures (which are subject to Article 45 of EU Directive 2004/18/EC relating to procedures for the award of public service contracts) and relevant statutory taxation requirements in relation to taxation of professional services provided to the public sector.

Tenders <u>must</u> include a statement that <u>none</u> of the circumstances listed in paragraphs 1 <u>and</u> 2 of Article 45 of EU Directive 2004/18/EC apply to them (interested parties are referred to Appendix 2).

The Commission reserves the right to cancel the tender process at any time should it see fit to do so.

Tenders <u>must</u> include a statement that the Commission will retain all intellectual property rights over all documents, records and reports produced (electronic and hard copy) and all such material shall be returned to the Commission upon the completion of the contract.

2.2 Specific Requirements

2.2.1 General

The purpose of this ITT is to engage the services of an experienced and suitably qualified professional contractor to provide detailed technical and economic advice on the options for the optimal strategy for the release of spectrum in the 900 MHz band.

The analysis in general should present; a consideration of the costs in terms of the running and administration of any chosen auction methodology, as well as the benefits of each auction type being considered for the future of the 900 MHz band: highlighting the one(s) that will best allow the Commission to fulfil its statutory objectives. This shall also include consideration of submissions from interested parties to ComReg 09/14.³

Analysis and recommendations are sought in relation to issues including, but not limited to:

2.2.2 Potential licence conditions

- Analysis of the costs, benefits, advantages and disadvantages regarding other
 potential licence conditions in light of the Commission's statutory functions and
 objectives, including but not limited to:
 - o coverage (its feasibility in terms of number of sites used), traffic projections, voice or data only, roll out conditions, "use it or lose it" licence conditions to avoid spectrum hoarding,
 - the nature and level of appropriate financial and other incentives which would encourage bidders to propose MVNO commitments in any release of 900 MHz spectrum,
- Benchmarking conclusions with international (best) practices, and in particular any similar work undertaken in any other CEPT Administration or European Member State: and
- Evaluation of conclusions in light of the particular circumstances in Ireland, including taking into account any relevant information supplied by the Commission.

2.2.3 Spectrum Auction Strategy

- Analysis and recommendation/s regarding the optimal allocation mechanism/s to release spectrum in the 900 MHz band (in whole or in part). This should involve consideration of issues including but not limited to:
 - o Analysis of different auction types,
 - o Benchmarking conclusions with international (best) practice, and in particular any similar work undertaken in any other CEPT Administration or European Member State; and
 - Evaluation of conclusions in light of the particular circumstances in Ireland, including taking into account any relevant information supplied by the Commission.

2.2.4 Specifics of Auction Design

- Analysis and recommendations regarding the specifics of the auction strategy recommended. This should involve consideration of issues including but not limited to:
 - o Ensuring equitable access to all lots,
 - Prevention of collusion before, during and after the recommended auction, including consideration of whether anonymity of bidders is required and what options are available in this regard,
 - o Strategies to avoid gaming as well as ensuring the transparency of the auction process,
 - o whether any reserve price is used or not and the respective advantages or disadvantages of this approach.
 - o Review of the practicalities of auctions e.g. Software, location of bidders, timing, etc;
 - o Availability and potential supply of suitable software to facilitate the desired auction type,

- Benchmarking conclusions with international (best) practice, and in particular any similar work undertaken in any other CEPT Administration or European Member State;
- Evaluation of conclusions in light of the particular circumstances in Ireland, including taking into account any relevant information supplied by the Commission:
- o Conducting modelling analysis; and
- o Setting out applicable auction mechanics, auction rules and their formulation suitable for publication including participation in any stakeholder workshops held by ComReg.

2.2.5 Spectrum fees

- Analysis and recommendations regarding the nature and level of spectrum fees for 900 MHz spectrum. This should involve consideration of issues including but not limited to:
 - The appropriateness of balancing of spectrum access fees relative to the build out of the network in the first 3 years of the licence;
 - O A suitable fee structure to encourage mobile operators which continue to use GSM 900 to phase-out GSM-only networks, having regard to factors including: spectrum efficiency (such as number of users and traffic supported per MHz), operational cost savings in terms of reduced power consumption, lower maintenance costs, and simplicity of interconnection etc:
 - Benchmarking conclusions with international (best) practice, and in particular any similar work undertaken in any other CEPT Administration or European Member State; and
 - Evaluation of conclusions in light of the particular circumstances in Ireland, including taking into account any relevant information supplied by the Commission.

2.2.6 Reserve Price

- Where a reserve price is used; analysis and recommendations regarding the methodology for determining the optimal reserve price, for 900 MHz spectrum and the appropriate reserve price itself. This should involve consideration of issues including but not limited to:
 - O A review of different methodologies that could be used to establish reserve prices for allocations of spectrum used to provide public mobile and other relevant services. This review should identify, amongst other things, the and reasoning and assumptions underpinning these methodologies and relevant economic, market and other factors used in these methodologies,
 - A review of the reserve prices used in other countries for the same or similar blocks of spectrum in the 900 MHz and 1800 MHz bands;
 - Benchmarking conclusions with international (best) practice, and in particular any similar work undertaken in any other CEPT Administration or European Member State; and
 - Evaluation of conclusions in light of the particular circumstances in Ireland, including taking into account any relevant information supplied by the Commission.

2.2.7 Liaison

Reviewing submissions made in response to ComReg Document 09/14⁶, assisting in the preparation of a further response to consultation and any subsequent information memorandum (IM).

2.2.8 Reports to Be Submitted

The successful tenderer will produce an interim and final report detailing the conclusions of the study, including all justification, modelling and assumptions used in reaching these conclusions. The exact format of each report will be detailed in the contract and as such communicated to the successful tenderer.

The successful tenderer shall be required to submit:

- All electronic reports in both Microsoft Word and Adobe PDF formats using a template as agreed in advance with the Commission;
- A back-up electronic copy of the reports on a CD-ROM, and
- A printed and bound copy of each complete report.

2.3 Price Quoted

The total price submitted in tenders <u>must</u> be inclusive of all costs associated with the project including; the preparation and if necessary the presentation of the written reports to the Commission, as well as any travel and accommodation costs the tenderer estimates are necessary.

Note: The total price submitted in tenders \underline{must} not exceed the threshold of $\underline{\textcircled{80,000}}$ Inclusive of V.A.T.

2.4 Equipment and software

The successful tenderer shall be responsible for procuring all of the necessary equipment, licences and software modelling required: to fully complete the analysis, to the standard agreed with the Commission.

2.5 Location and Confidentiality

The successful tenderer will be required to work alongside Commission staff and other advisers from time to time. Where face to face meetings are required these will be held at the Commission's premises in Dublin unless otherwise agreed by the Commission. The confidentiality of the work will be protected at all times. Tenders <u>must</u> include a signed copy of the confidentiality statement in Appendix 1.

2.6 Duration of the Assignment

The following timescale indicates key deadlines in the project:

Results of Tendering Process to be communicated to all parties by the end of May 2009 or as soon as possible thereafter; and

• Target date for commencement of the project: May/June 2009;

• Target date for the submission of the first report, 30 June 2009, second report 30 September 2009.

It is intended to put the contract in place for the period May/June 2009 until June 2010.

2.7 Other Information

The successful tenderer shall be required to:

- Comply with the requirements for the awards of Irish public sector contracts;
- Enter into a formal and binding contract for the work specifications required.

3 Conditions of Tendering

Detailed contractual arrangements are not within the scope of this document. However, the following conditions of tendering apply. By responding to this ITT, tenderers agree to be bound in all respects by all of the terms and conditions contained herein. Prior to the deadline for the receipt of tenders the Commission may delete, vary, amend or extend any item or requirement in this ITT.

3.1 Financial Status of Successful Contractors

Before contracts are awarded, the successful contractor (and agent, where appropriate) will be required to comply with the prevailing tax clearance procedures.

A successful tenderer will be required to promptly produce a Tax Clearance Certificate from the Irish Revenue Commissioners. In addition, such contractors shall be required to retain records of tax reference numbers for any sub-contractors, whose payments exceed €635 including VAT.

Application for a Tax Clearance Certificate may be made to the Irish Revenue Commissioners by way of a standard form which will be provided to the successful tenderer by the Commission in due course.

Where a Tax Clearance Certificate expires during the course of the contract, the Commission will require a renewed certificate or statement. All payments under the contract will be conditional on contractors being in possession of valid certificates at all times. In addition, all payments will be subject to Withholding Tax as laid down by the Revenue Commissioners.

3.2 Conflict of Interest

Tenders <u>must</u> include a statement that the tendering party does not have any conflict of interest. Any conflict of interest involving a contractor (or contractors in the event of a group or consortium bid) <u>must</u> be fully disclosed. This includes any registerable interest involving the contractor and the Commission or their relatives. In the event of a conflict of interest only coming to their notice after the submission of the tender and prior to the award of the contract the circumstances shall be communicated to the person specified at Section 3.7 immediately upon such information becoming known to the tenderer. The terms "registerable interest" and "relative" shall be interpreted as per Section 2 of the Ethics in Public Office Act 1995.

3.3 Duration of Contract

It is intended that this ITT will give rise to a contract for the provision of the services in question, to the Commission from the date of commencement of the contract for a period ending on 30 June 2010. The contract will include *inter-alia* clauses relating to early termination, e.g. liquidation of the contractor, failure to provide agreed services etc.

3.4 Information Supplied by Tenderer(s) to be Contractually Binding

Information supplied by tenderer(s) will be treated as contractually binding and the Commission, reserves the right to seek further clarification or verification of any such information.

3.5 Costs incurred in Preparing Tenders

The Commission will not be liable in respect of any cost incurred by service providers in the preparation of tenders or any associated work effort including subsequent travel to present the tenders.

3.6 Time Available for The Commission to Accept Tenders

All tenders <u>must</u> include a statement that the offer will remain open for no less than 4 calendar months from the closing date for receipt of tenders.

3.7 Submission of Tenders

Tenders <u>must</u> be completed in accordance with the format described in Section 4 of this document.

Tender submissions <u>must</u> include <u>three printed copies</u> of the tender.

3.8 Deadline for Receipt of Tenders

Applications <u>must</u> be received on or before <u>12.30 PM</u> (Irish Time) on <u>22 May 2009</u>.

3.9 Acceptance of Tenders

- 3.9.1 The Commission reserves the right at its sole discretion, to accept or reject any tender (in whole or in part) and to waive any informality or irregularity. Furthermore the Commission is not bound to accept the lowest priced tender or any tender.
- 3.9.2 The contract if awarded shall be awarded to the tenderer that has submitted:
 - A tender in <u>full compliance with all mandatory requirements</u> set out in this Invitation to Tender and the conditions of tendering herein; and
 - A tender which has been assessed to be the most economically advantageous proposal by reference to the award criteria as outlined in Section 6 herein.
- 3.9.3 If a tender is accepted, written notification of acceptance of a tender will be given to the successful tenderer and no tender shall be deemed to be accepted until such notification has been given.

3.9.4 The Commission may make acceptance of any tender conditional upon the tenderer providing (at the tenderer's expense) such security for the due performance of the contract The Commission may require.

This procedure is then concluded by a contract signed by the parties involved.

4 Format of Tender

All costings for the project **<u>must</u>** be quoted in Euro. Any exchange rate risk will be borne by the tenderers.

Tenders <u>must</u> state the total inclusive cost for the minimum contractual requirements outlined in this document.

Tenders <u>must</u> also include an itemised breakdown of the total cost which distinguishes between labour costs and associated overheads such as travel and subsistence.

All information arising from the tender process will be and shall, remain the property of the Commission. A statement confirming agreement with this requirement <u>must</u> be included in the tender.

4.1 General Information

Tenders **must** include the following:-

- a) Name, address, telephone and fax number of the tendering organisation⁷ including the name of person within the tendering organisation dealing with the matter;
- b) In the case of a consortium, the name, address, telephone and fax number of any third-parties involved in the tender. Name of person within third-party business dealing with the matter;
- c) In the case of a consortium, a description of role or element of contract to be fulfilled by any third-party;
- d) In the case of a consortium, identification of the person who will carry overall responsibility for the contract and his/her position within the contracting company/business;
- e) A statement confirming acceptance by the tenderer and any third parties of the conditions of tender described in Section 3 of this document.

4.2 Details of the Tendering Firm

During the evaluation, the suitability of tenderers will be checked by reference to their financial and economic standing and professional capability.

4.2.1 Economic and Financial Standing

Tenders **must** include the following:-

(a) An appropriate statement from an appropriate <u>financial institution</u> providing evidence of the tendering party's financial standing;

- (b) Presentation of the tenderer's <u>audited accounts</u> or <u>balance sheets</u>, where publication of the above is required under company law in the country in which the service provider is established;
- (c) A statement of the tenderer's overall turnover <u>and</u> its turnover in respect of the services to which this contract relates for the three previous financial years;
- (d) An appropriate statement from an appropriate <u>financial institution</u> providing details of the relevant professional indemnity insurance;
- (e) A statement from the tenderer that <u>none</u> of the circumstances listed in paragraphs 1 and 2 of Article 45 of EU Directive 2004/18/EC apply to them (copy of Article 45 attached at Appendix 2).

4.2.2 Capability of Tendering Parties

Tenders **must** include the following:-

- (a) The relevant professional qualifications of the personnel, including managerial personnel, who would be responsible for providing the services under the contract. Current curriculum vitaes⁸ outlining details of similar projects on which they have worked, their specific responsibilities in relation to such projects together with details of formal qualifications or expertise suited to the conduct of the work under tender:
- (b) Identification of the project staff responsible for quality control;
- (c) A statement of the service provider's average annual manpower, and the number of managerial staff, for the last three years;
- (d) A statement of the service provider's proposed modelling equipment and software; including its full capabilities in terms of carrying out the services under tender; and
- (e) A description of the service provider's measures for ensuring quality, which are relevant to this contract.

4.3 Resource Allocation

A full description <u>must</u> be provided to the Commission of; the measures in place, including those to deal with; staff absences, equipment or software failure, management, the nature and level of supervision which will be provided to ensure that a high quality service will be delivered.

4.4 Detailed Proposal

Tenders must include the following:-

- (a) A detailed statement of the tenderer's understanding of the assignment and the work to be performed;
- (b) A detailed description of the individuals proposed for the assignment, in particular, position within the firm, number of years with the firm, proposed role/responsibility in the assignment, description of previous relevant projects and experience;
- (c) A statement on conflict of interest: The proposal <u>must</u> contain a clear statement that there is no existing or potential conflict of interest in relation to the proposed assignment.
- (d) A statement regarding the property of information arising from the assignment contract: The tenderer <u>must</u> clearly state in the proposal document that he/she agrees that all information arising from any contract that might be awarded will be and shall remain the property of the Commission. In particular, tenderers <u>must</u> include a statement to the effect that copies of all working papers and supporting material arising from the project will be made available to the Commission on request;
- (e) A sample report of similar work.

The work <u>must</u> be conducted in English and all deliverables <u>must</u> be submitted in English.

4.5 Relevant Experience and References

In order to evaluate the of experience of tendering parties in providing the required services, tenders <u>must</u> include the names, addresses and telephone numbers of <u>not less</u> <u>than three</u> existing customers who may be contacted by the Commission to provide references in connection with the proposed services.

There will be a period during which prospective tenderers may request clarification on issues specific to the submission of a competitive tender based on the terms of reference or any other points of clarification which are deemed relevant to this project. In particular, tenderers shall immediately notify The Commission should they become aware of any ambiguity, discrepancy, error or omission in this Invitation to Tender.

All points of clarification <u>must</u> be submitted in writing and should be labelled "Questions: Spectrum Liberalisation in the 900 MHz and 1800 MHz Bands" and should include full details i.e. name, contact person address, fax no, e-mail of the party posing the question. Questions addressed in any other way will not be answered. The latest time, without exception, for receipt of questions is <u>12.30 PM</u> on Friday <u>15 May 2009</u>.

All questions and answers will be circulated to companies who have signalled interest in tendering as soon as possible after this date. The Commission will not however disclose the identity of any party posing a question, except where it is legally obliged to do so.

Whilst every endeavour is made to provide accurate information to potential respondents regarding the requirements for this contract, tenderers should form their own conclusions about the methods and resources needed to meet those requirements. The Commission cannot accept responsibility for the tenderers assessment of this assignment.

6 Evaluation of Tenders and Award Criteria

The contract will be awarded on the basis of the most economically advantageous tender (MEAT) applying the following criteria, with the individual weighting of each criterion being indicated in parentheses:

- (i) demonstrated understanding and analysis of the requirements (25 points),
- (ii) comprehensiveness and quality of the approach proposed (25 points),
- (iii) the experience, expertise and qualifications of the team. Regard will be had as to the participation of team members with previous experience of similar initiatives (20 points),
- (iv) the stated ability of the tenderer to manage the project effectively and to complete it within the required time-scale (10 points); and
- (v) Overall Cost (20 points);

N.B.:- All responses to this tender will be opened at the same time, after the deadline for receipt of tenders. The evaluation criteria will not be changed without prior notification to all applicants.

Tenderer(s) should note also that a further selection stage involving presentations and interviews may be necessary at short notice in order to select the successful candidate.

Appendix 2 - Article 45 of EU Directive 2004/18/EC

ARTICLE 45 OF EU DIRECTIVE 2004/18/EC9

Personal situation of the candidate or tenderer

- 1. Any candidate or tenderer who has been the subject of a conviction by definitive judgment of which the contracting authority is aware for one or more of the reasons listed below shall be excluded from participation in a public contract:
- (a) participation in a criminal organisation, as defined in Article 2(1) of Council Joint Action 98/733/JHA ¹⁰;
- (b) corruption, as defined in Article 3 of the Council Act of 26 May 1997 ¹¹ and Article 3(1) of Council Joint Action 98/742/JHA ¹² respectively;
- (c) fraud within the meaning of Article 1 of the Convention relating to the protection of the financial interests of the European Communities ¹³;
- (d) money laundering, as defined in Article 1 of Council Directive 91/308/EEC of 10 June 1991 on prevention of the use of the financial system for the purpose of money laundering ¹⁴.

Member States shall specify, in accordance with their national law and having regard for Community law, the implementing conditions for this paragraph.

They may provide for a derogation from the requirement referred to in the first subparagraph for overriding requirements in the general interest.

For the purposes of this paragraph, the contracting authorities shall, where appropriate, ask candidates or tenderers to supply the documents referred to in paragraph 3 and may, where they have doubts concerning the personal situation of such candidates or tenderers, also apply to the competent authorities to obtain any information they consider necessary on the personal situation of the candidates or tenderers concerned. Where the information concerns a candidate or tenderer established in a State other than that of the contracting authority, the contracting authority may seek the cooperation of the competent authorities. Having regard for the national laws of the Member State where the candidates or tenderers are established, such requests shall relate to legal


and/or natural persons, including, if appropriate, company directors and any person having powers of representation, decision or control in respect of the candidate or tenderer.

- 2. Any economic operator may be excluded from participation in a contract who:
- (a) is bankrupt or is being wound up, whose affairs are being administered by the court, who has entered into an arrangement with creditors, who has suspended business activities or who is in any analogous situation arising from a similar procedure under national laws and regulations;
- (b) is the subject of proceedings for a declaration of bankruptcy, for an order for compulsory winding up or administration by the court or of an arrangement with creditors or of any other similar proceedings under national laws and regulations;
- (c) has been convicted by a judgment which has the force of res judicata in accordance with the legal provisions of the country of any offence concerning his professional conduct;
- (d) has been guilty of grave professional misconduct proven by any means which the contracting authorities can demonstrate;
- (e) has not fulfilled obligations relating to the payment of social security contributions in accordance with the legal provisions of the country in which he is established or with those of the country of the contracting authority;
- (f) has not fulfilled obligations relating to the payment of taxes in accordance with the legal provisions of the country in which he is established or with those of the country of the contracting authority;
- (g) is guilty of serious misrepresentation in supplying the information required under this Section or has not supplied such information.

Member States shall specify, in accordance with their national law and having regard for Community law, the implementing conditions for this paragraph.

- 3. Contracting authorities shall accept the following as sufficient evidence that none of the cases specified in paragraphs 1 or 2(a), (b), (c), (e) or (f) applies to the economic operator:
- (a) as regards paragraphs 1 and 2(a), (b) and (c), the production of an extract from the "judicial record" or, failing that, of an equivalent document issued by a competent judicial or administrative authority in the country of origin or the country whence that person comes showing that these requirements have been met;
- (b) as regards paragraph 2(e) and (f), a certificate issued by the competent authority in the Member State concerned.

Where the country in question does not issue such documents or certificates, or where these do not cover all the cases specified in paragraphs 1 and 2(a), (b) and (c), they may be replaced by a declaration on oath or, in Member States where there is no provision for declarations on oath, by a solemn declaration made by the person concerned before a competent judicial or administrative authority, a notary or a competent professional or trade body, in the country of origin or in the country whence that person comes.
