

## Multi Band Spectrum Award – ComReg lodges appeal against High Court order granting stay on implementation of the Auction

Information Notice ComReg 22/70

1. On 22 July 2022, ComReg published an Information Notice (<u>Document 22/62</u>), which noted, amongst other things, that on 21 July 2022, Mr Justice McDonald in the High Court made an Order granting a stay on the implementation of the Main Stage (i.e., the Auction) of the Multi Band Spectrum Award<sup>1</sup> pending the delivery of judgment in the main proceedings<sup>2</sup> by Mr Justice O'Moore ("Stay").

- 2. On Monday 25 July 2022, ComReg lodged an Appeal<sup>3</sup> against the Order granting the Stay.
- 3. On Friday 29 July 2022, the Court of Appeal made directions setting the appeal down for hearing on Wednesday 19 October 2022.
