1 Introduction

In accordance with the terms of Regulation 22 of the Framework Regulations, ComReg is vested with responsibility for the management and administration of the national telecommunications numbering resource. When the level of "free" numbers (i.e. the quantity of numbers that are available for allocation) approaches a critical level, changes to the numbering scheme are necessary to ensure that sufficient numbers continue to be available to all authorised entities, and subsequently to endusers. This paper sets out proposals for the further development of the scheme, identifying specific number change areas, having particular regard to:

- the requirement to ensure an adequate supply of numbers and codes;
- the need to minimise disruption to users from number changes;
- efficient allocation and use of numbers.

2 Background

In 2001 ComReg, then the ODTR, conducted a comprehensive review of the Irish telecommunications numbering scheme. This paper set out an evolutionary approach for the development of the numbering scheme, where changes to the scheme would happen in line with requirements.

At that time, it was noted that since liberalisation of the telecommunications market in December 1998, there has been a heavy demand for additional telephone numbers including numbers to cater for the start up requirements for newly licensed operators. Given that level of demand, it was forecast that some geographic numbering areas would reach number exhaustion within the next few years. These areas would require a change to longer subscriber numbers in order to ensure continuity of number supply. A series of number changes were introduced over the period 2002 – 2003 for the areas which were in need of immediate expansion and rationalisation. In addition, a number of geographic areas were flagged for expansion in the future but no date was set as any changes would be subject to future demand.

Some of the number changes, which were flagged in D11/01, now need to be implemented. These capacity driven changes also incorporate measures to simplify and clarify the numbering scheme, i.e.:

- replacing 4 digit STD Codes with 3 digit Codes;
- merging STD Code Areas;
- recovery of STD Codes for re-use;

None of these changes will lead to instances where calls, which have been local rate calls, become more expensive.

3 Notice of Number Changes in 044, 0502, 0506, 0509, 053, 054 and 055 Areas.

In D11/01, provision was made for changes within the 044, 0502, 0506, 0509, 053, 054 and 055 areas. A critical level of available free numbers has now been reached in the 0502, 0506, 0509 (Laois/Offaly) areas, the 044 (Westmeath) area and the 053, 054, 055 (Wexford) areas. As a consequence, number changes are now necessary. The number changes will entail prefixing the existing 5-digit local numbers with an extra two digits in the aforementioned STD Code Areas. In addition, some rationalisation of STD Codes will be carried out². These changes are detailed in Annexes 1 to 3.

The new numbers will be activated to work in parallel with the old numbers at the beginning of December 2005. During the six month parallel working period, it will be possible to make calls using either the old or new numbers. This period will allow telephone users to become familiar with the new numbers and will also facilitate the updating of stationery, advertising, telephone equipment, etc by subscribers in the affected areas.

The actual number change dates (i.e. the dates from when only the *new* number will be operational) will be phased in from May 2006. After the number change date for a particular number change area, calls dialled to the old numbers will be routed to recorded announcements.

4 Further Information


For each area where a number or code change is required, ComReg issues a detailed change plan to provide telephone users with information on the changes and facilitate preparatory work by network operators – see Annexes 1 to 3. Consumers should contact their telecommunications service provider in the first instance for more information on these changes.




