- 2. Please submit an application fee of £10 in respect of each proposed point to point radio link with the completed application form. (e.g. if 5 links are being applied for then £50 would be required.) Failure to pay the required amount will result in your application not being processed.
- 3. As outlined in the guidelines, there are limitations on the number of radio links an applicant will be licensed for in certain bands. If it transpires that multiple applications are being made to overcome this limitation the application will be rejected.
- 4. Your application will be assessed on your responses in the application form with any supporting information attached.
- 5. Every effort will be made to clear applications quickly so operations can start at the earliest possible date. To facilitate speed of processing, please ensure that your application is complete and clearly set out (typed). Incomplete applications may be returned requiring resubmission.

- ii. the channel bandwidth and (if digital) the corresponding capacity obtainable.
- iii.copy of the spectrum mask for both transmitter & receiver,
- iv. spurious emission levels for both transmitter & receiver,
- v. co-channel and adjacent channel carrier to interference ratios for the receiver,
- vi. receiver sensitivity levels for a BER of 10-6.

4.2 Feeder Equipment and Antennas

For antennas proposed, please supply details on the make, size, type and Radiation Pattern Envelope (RPE).
