## **1 Introduction**

This information notice confirms ComReg's review and approval of the proposed text changes to eircom's Reference Interconnect Offer as per Decision Notice D10/02 (ODTR Doc 02/55).

## 2 Reference Interconnect Offer Text Change

### 2.1 RIO Text Changes

#### 2.1.1 *Summary of Consultation Issues*

On the 11/11/02, eircom posted a proposed text change of their Reference Interconnect Offer from version 2.6 to version 2.7, also from Version 12 to 13 of the Switch Transit Routing and Price List and finally, the proposed introduction of the Operator Price List on its website thereby notifying all interested parties of the proposed changes in line with Decision Notice D10/02 (ODTR Doc 02/55). Interested parties had twenty one days in which to submit comments to ComReg.

#### 2.1.2 *Views of Respondents*

No submissions were received regarding the proposed text change.

#### 2.1.3 *ComReg's Position*

The RIO review process is set out in Decision Notice (D10/02) and is most likely to conclude with a consultation following which a direction will be made as regards changes to the RIO text since RIO version 2.2. The following comments are given in that context and the issues herein may be subject to further review at that time.

The adjustments shown in *eircom's* proposed RIO version 2.7 may be subject to a further review of published Service Schedule 104. The following comments are given in that context.

ComReg confirms that *eircom* are to make the following adjustments to the Proposed RIO version 2.7 prior to transferring these changes to the formal RIO

Clause 29.3 is to be replaced with the following text “In the context of Number Translation Codes, amendments, changes and/or modifications to the *eircom* Switched Transit Routing and Price List shall not be subject to the requirements of Clause 29.1. Amendments, changes and/or modifications to the *eircom* Switched Transit Routing and Price List shall be effective and binding upon Operator in accordance with the terms and conditions of published Service Schedule 104 provided the processes for price changes and the introduction of new services as set out in Appendix 1 of the *eircom* Switched Transit Routing and Price List are complied with. Such changes shall not require separate written agreement between the parties to take effect”.

Clause 29.4 is to be replaced with the following text “ In the context of Number Translation Codes, amendments, changes and/or modifications to the Operator Price List shall not be subject to the requirements of Clause 29.1 where expressly provided in the Service Schedule and provided the parties follows the processes in Appendix 1 of the Operator Price List.
