Telecoms Regulator to review National Numbering Scheme for Telephony in Ireland

Etain Doyle, Telecoms Regulator today Wednesday (20th December 2000) announced that she is to review the National Numbering Scheme for Telephony in Ireland. This is a major review that looks at future needs for all telephony and related numbers. It forecasts trends for the period 2001-2005 and presents proposals for the future development and management of the whole numbering resource. She has issued a consultation paper on the matter and is seeking the views of interested parties.

The review includes ordinary geographic telephone numbers and STD codes, non-geographic numbering, such as freephone, premium rate and personal numbers, and special short codes of all kinds such as operator assistance. The geographic numbers being reviewed affect all areas of the country, many of which could face shortages during the 5-year period being considered. The review proposes a range of solutions to deal with this.

According to the Regulator "Liberalisation and the introduction of new technologies and services has created an unprecedented demand for numbers and codes. It is therefore timely to once again review the scheme and to provide a clear medium to long term numbering strategy."

In the current consultation paper the Telecoms Regulator sets out some proposals for the future development of the numbering scheme. She is conscious that the plan should be user friendly and that there is an adequate supply of numbers and codes. However there is a need to minimise disruption to users from number changes and

keep costs of number changes to an acceptable level. Proposals are also included to

minimise inefficiencies introduced by the current industry-standard process of

allocating numbers to operators in large blocks.

The ODTR proposes to simplify and clarify the current geographic numbering area

regime. The overall approach has been to develop a forecast of demand for numbers

over the planning period of 2001-2005. Number changes will be required to provide

additional capacity but these changes will also provide an opportunity to

simultaneously rationalise and simplify the National Numbering Scheme. The ODTR

estimates that by the end of 2005 the total cumulative growth in number requirements

will be 74%.

The Regulator added "While the range of services available to users is expected to

significantly expand and evolve over the next few years the national numbering

scheme must be able to accommodate these changes in a way that maintains an

acceptable level of user friendliness. The outcome of this review will set the

numbering scene for the next five years of operation. I am very anxious to hear from

all interested parties particularly consumers and their representatives."

The consultation period will run from Wednesday 20th December 2000 up to Friday

23rd February 2001 and the ODTR welcomes views from all interested parties

including consumers, their representatives and local community representatives.
