- On 29 September 2017, ComReg received a request from eir in respect of Oxera's 2010-11 Unfair Burden Assessment Report (ComReg document 17/73C). eir requested clarification as to source of the 2009/10 ROCE calculation of 24.5%, and the 2010/11 ROCE calculation of 26.1%<sup>1</sup>, or the underlying calculations.
